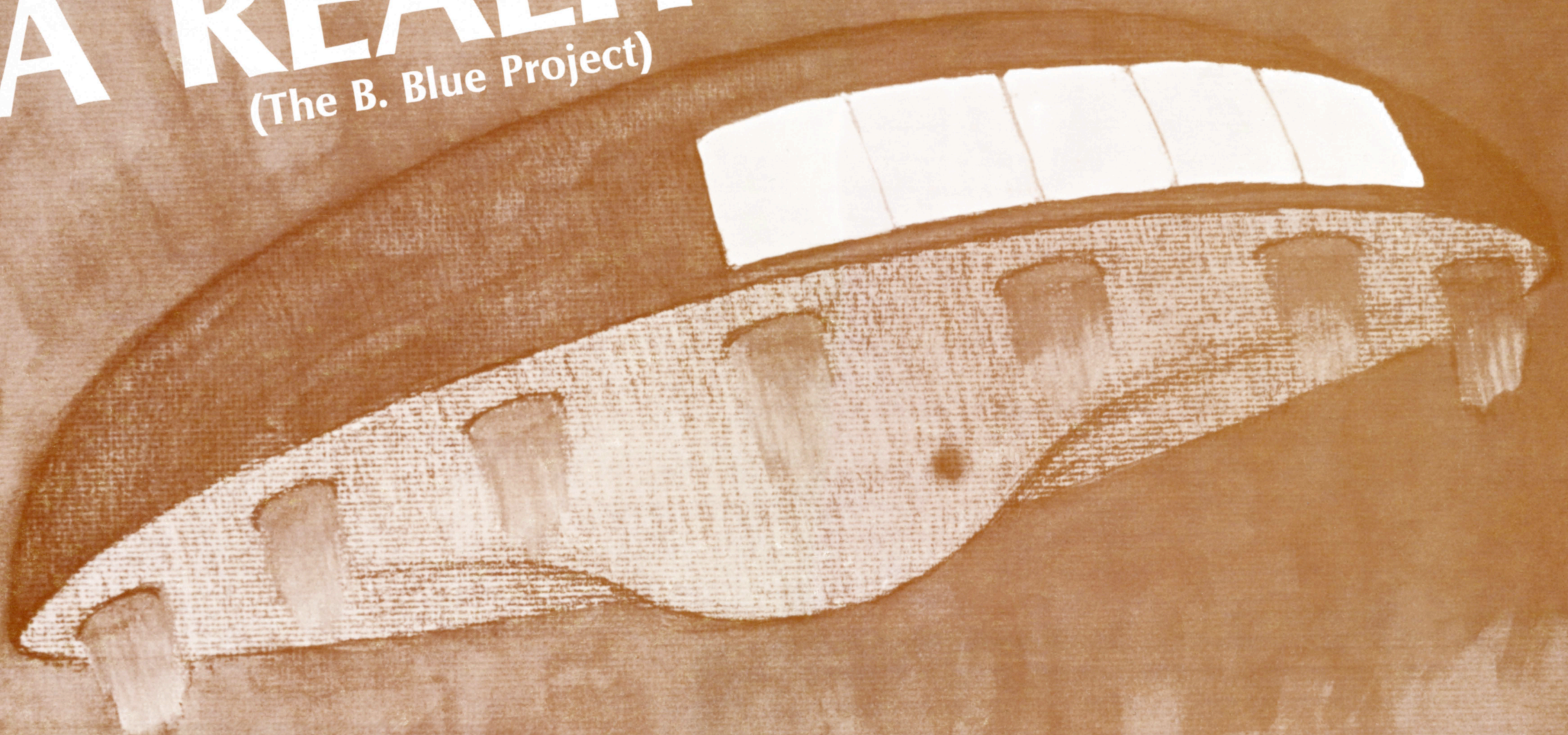


# ARE UFO'S A REALITY?

Well, first of all, let me begin by saying I have found that 80% of all inflow information has to be immediately discarded as pure nonsense, and the remaining 20% has to be carefully examined and researched. How does one determine what constitutes the 20%? By communicating directly with the source of information, or with someone of known credibility who has done so, it is possible to determine what is fiction or seemingly fact.

Due to limited space, it is of course impossible to present all of the evidence surrounding the UFO mystery on one album, but on the grooves within, you will find a serious evaluation . . . men who are noted in their field, and scientists who have dedicated many long years to UFO research, by actually traveling to the location of a reported sighting, talking with actual witnesses and evaluating their claims.
